



4. **RELATIONSHIP:**

Nothing in this MOU shall be construed to make party a partner, an agent or legal representative of the other for any purpose.

5. COSTS OF THE MOU:

Each Party shall bear the respective costs of carrying out the obligations under this MOU.

6. TERM AND TERMINATION:

This MOU will continue in effect until it is terminated by one of the parties. Either Party may terminate this MOU at any time for any reason upon 30 days written notice to the other party. This MOU unless extended by mutual written agreement of the parties, shall expire 3 years after the effective date specified in the opening paragraph. This MOU cannot be amended or terminated either by mutual written agreement of the parties at any time.

LEGAL JURISDICTION

This MOU is subject to the prevailing Indian Laws. In the event of any portion of the agreement not being tenable/ enforceable under the prevailing laws, only such portions of the agreement shall stand effected and the other portions of the agreement shall remain relevant and unaffected. The Legal Jurisdiction of the courts shall be in Coimbatore, India.
